We did not compute the sample size and replicate number but determined appropriate numbers from similar experiments in the literature.

The number of cells imaged per experiment is indicated in the figure legends. For each microscopy experiment, we recorded at least $n > 10$ cells without technical or biological repetition. We also performed several technical replicates and obtained similar results, but these were not included in the manuscript as they were done with different microscope settings/experimental conditions. Samples were prepared independently for FRAP and single-molecule experiments. For FRAP data analysis, we excluded cells that moved significantly during the recovery period.
