The concept of sample size does not apply to our study. However, we did have to think deeply about the range of valencies that we “titrated” in our simulations as well as the range of linker lengths. These choices were made to connect with the experimental work performed in the Rosen lab.

Each simulation was performed at least 50 separate times using a different random seed for each trial. The goal was to generate reproducible statistics as judged by the similarities between calculated phase diagrams from one simulation to the next.

Most of the results we show are either explicit 1- and 2-dimensional histograms or the result of calculating first moments of specific quantities such as the fraction of molecules in the single largest cluster or the relative densities of molecules vs. the entire lattice. Given the large sizes of the simulation boxes, the large numbers of coarse-grained molecules that we deploy in the simulation cells, and the overall statistical efficiency of the sampling, the standard errors about the mean are typically in the second and third decimal places.

This table provides a detailed inventory of the UNIPROT identities, the Pfam domains, the Gene Ontology annotations, and the sequences of linkers that fit into specific intervals of the numerical parameter, Δ that we use as a proxy for quantifying the effective solvation volumes of linkers.
