All statistical analysis (i.e. estimation of p-values and effect sizes using our method) description is given in the "Statistical analysis" subsection of "Methods and materials". Exact p-values and effect sizes are given in Table 2. To correct for multiple testing we use the Holm correction, which is stated in the caption of Fig. 2.
