No statistical tests were used to pre-determine sample size. Our sample sizes for each experiment are similar to those generally reported in the field. Sample sizes are reported in respective figure legends.

Replicates

The number of biological replicates for each experiment is described in the respective figure legends. Biological replicates equals technical replicates for all experiments reported. No data points were excluded. Criteria for exclusion/inclusion for whole-cell patch clamp experiments are outlined in the Methods section. In the event of an open eyelid, those animals were not used for experiments, as outlined in the Methods section.



Statistical reporting

Statistical analyses for each experiment are described in the Figure Legends and Methods section in the main text. P-values are reported in the main text and in Supplemental Table 1 for the Intrinsic Signal Imaging data.

Experiments were performed on littermate controls for all experiments unless that littermate was not usable due to eyelid suture opening for example. This information is outlined in detail in the Methods section. All experiments were performed blind to genotype until data collection and analysis was completed.
