The number of experiments (n) is indicated in each figure panel.
For single cell measurements in cancer cells and *Xenopus* oocytes, values from each cell are defined as biological replicate. For pull-down assays and western blots, each pull-down or batch of cell lysates is defined as biological replicate, while each blot carried out with the same batch of pull-down eluent or cell lysate is defined as technical replicate. In the figures the numbers of technical / biological replicates are separated by a dash.
No outliers were excluded from data analysis.

All data shown in the figures is presented as mean values + standard error of the mean (MW + SEM). Statistical test used, are indicated in each figure legend. N values are indicated directly in the figures. For calculation of significance in differences, Student's t-test was used. Furthermore, data for all values shown in the figures are provided in the figure supplements to allow reevaluation of the data with any alternative statistical test.
