No statistical methods were used to predetermine sample sizes, but our sample sizes are similar to those reported in many previous publications. All sample size values are indicated explicitly in figure legends.

Replicates

- You should report how often each experiment was performed
- You should include a definition of biological versus technical replication
- The data obtained should be provided and sufficient information should be provided to indicate the number of independent biological and/or technical replicates
- If you encountered any outliers, you should describe how these were handled
- Criteria for exclusion/inclusion of data should be clearly stated
- High-throughput sequence data should be uploaded before submission, with a private link for reviewers provided (these are available from both GEO and ArrayExpress)

All this information can be found in our Materials and methods. We indicate whether our replicates are biological or technical. When data are excluded, we state it clearly. Sample sizes are indicated explicitly in figure legends.

Statistical reporting

- Statistical analysis methods should be described and justified
- Raw data should be presented in figures whenever informative to do so (typically when N per group is less than 10)
- For each experiment, you should identify the statistical tests used, exact values of N, definitions of center, methods of multiple test correction, and dispersion and precision measures (e.g., mean, median, SD, SEM, confidence intervals; and, for the major substantive results, a measure of effect size (e.g., Pearson's r , Cohen's d))
- Report exact p-values wherever possible alongside the summary statistics and 95% confidence intervals. These should be reported for all key questions and not only when the p-value is less than 0.05.

Statistical analysis methods are described in Materials and methods as well as in all figure legends. Exact values of N, definitions of center and error bars are indicated in figure legends. Exact p-values are reported in figure legends.
