An appropriate sample size was not computed when the study was designed, and no explicit power analysis was used. For each experiment, sample size is indicated in the figure legend, figures (Fig. 4C, 5B, 7B) or text (Fig. 7C) and was chosen based on standards in the field and references including van Bergeijk et al., 2015 and Wagner and Glotzer, 2016.

Experiments were repeated at least three times to ensure reproducibility and consistency as indicated in the figure legends. We provide details about our criteria for quantification of cortical fluorescent signals and spindle displacement in the Materials and Methods section.
