The number of images and image categories used in each task is giving the corresponding Methods section. Outliers were displayed as dots in box and whisker plots (as seen in Figs 1, 2, and 5). In the orientation detection task, the vertical orientation was removed from the analysis because the pre-attention performance level was an outlier (explained in Sec. 2.4)



## Statistical reporting
