Figs 3 & 6. These were not testing a binary hypothesis, and so a conventional power analysis is not appropriate. The legend explains that 19 replicates were used and the standard errors for both frequency and power change provide a 95% confidence interval for the characteristic relationship to phase differences. Fig 4: An explicit power analysis was not used for this experiment, because the same dataset was examined to test for several interlinked hypotheses, namely that changes in oscillation power were accompanied by systematic changes in phase dispersion or spiking, and that changes in oscillation frequency were accompanied by changes in spike phase. Fig. 7: this figure illustrates two examples out of 8 cells.

### **Replicates**
