This is a descriptive fate mapping study of hindbrain development. Correspondingly, we have not generated quantitative data or performed statistical analysis. We make no statistical claims.

Our conclusions are based on positive observations (in more than 3 independent experiments) of cell labelling corresponding to a given enhancer element.
