The number of mutant embryos, pools of embryos, and cell culture replicates are indicated in the corresponding figure legend. For mutant embryos, at least 3 independent embryos were analysed (between 3 and 11). Analysis of single blastomeres were always related to more than one embryo (from 75 to 428 blastomeres, between 2 and 6 blastocysts, and 28 morulae). Transient transgenic assays were performed, at least, in 75 embryos. Between 4 and 13 pools of embryos were used for RT-qPCR analysis. Cell culture assays were performed, at least, in 6 replicates. Sequencing data has been uploaded to GEO database with the following accession number GSE121979.
