No power analysis was used. Sample size could not be predetermined because analogous experiments have not been performed previously, hence the effect size and variance was not known in advance. We collected as many cells as possible from each animal. N values for cells are listed in the legends.

All N values are reported in the text. Technical replication is not relevant for the present study. No outliers were excluded based on deviations from our hypotheses. Individual data points are included in the scatter plots.
