We did not complete a formal power analysis for the current fMRI study. However, our sample size was selected to be comparable with a previous study that also investigated changes in functional connectivity with memory using psychophysiological interaction (PPI) analyses (King et al., 2015). We conducted a single human fMRI experiment. Information concerning our criteria for exclusion of data can be found in the Materials and Methods, Participants section and the Analyses, Behavioral Analyses section. In total 6/34 participants were excluded from analyses of fMRI and behavioral data.
