Sample sizes and statistical tests are reported in the Figure legends and Material and Methods Section.

For electrophysiological experiments, the power analysis was performed using data from preliminary studies with G\*Power v3, applying 0.8 as desirable power, and alpha equal to 0.05. A group of 12 cells provides sufficient power to detect significant changes in the proposed electrophysiological studies.

For biochemical/behavioral/histological data, both our preliminary results and the literature using the same model were used to define sample size (PMIDs 24231806, 22653057, 20534480).

For behavioral/biochemical/histological studies, each animal is considered as a biological replicate. For electrophysiological studies, each recorded cell was considered a biological replicate.

A technical replicate is defined as repetition of the same experiment, using the same samples. Technical replicates were ran whenever possible.

For microarray analysis, data are publicly available. GEO accession number is described in Materials and Methods section.

No outliers were encountered and no data were excluded.

All animals were randomized for homecage position and test chamber assignment during behavior. Given the severe phenotype of the KO mice, we did not perform blind randomization for behavioral studies.
