The study did not use explicit power analysis to collect the results. The sample size ranged between 2-8, in some cases with triplicate samples. It is not possible to predict successful experiments for the use of this new fluorescent labeling reagent. Each experiment was done in parallel with negative control. The results are completely transparent with the positive and negative samples.
