With the dynamic clamp experiment, we aimed at a further test of the short-term memory mechanism by cooperative ion channels. After a series of test recordings to establish the dynamic clamp software, we recorded three neurons from layer II of the perirhinal cortex. All three cells exhibited graded persistent activity in the presence of the emulated cooperative channels. We see this as sufficient support for our theoretical prediction that the mechanisms is generic and robust enough to work in a biological neuron.
