The statistical test and p value for each test is found in the legend corresponding to each figure letter. The definition of N is found at the bottom of the legend for each figure. Measures of center (in most cases, the median) are found in the text where the major results are described. Raw data is shown in every figure, in the form of a scatterplot overlaid on a bar graph when N < 40 or as a cumulative distribution otherwise.
