Biological replicate numbers (ie. N values) are reported throughout the manuscript (ex. Results section, line 42). Technical and biological replicates were discussed in the Methods (lines 127-130). The definition of N, the biological replicate, is also in line 130 and in lines 153. No outliers were encountered and no data was excluded.

Statistical testing was described in Methods, line 153-157. Raw data points were included in Figures wherever possible. The same test (non-parametric randomization test) was used for all experiments. No multiple test correction is needed for this test. All N values, means and SEMs and exact p values (or estimates where $p < 0.00001$) are reported throughout the text of the Results and Discussion (ex. Results line 42).

Does not apply. As we are primarily introducing mutations into ion channels, the mutation is the only variable. No need for randomization. Furthermore, our analysis leaves little room for unconscious bias and our effect size is often 10-100 fold. Masking or blinding is therefore unnecessary.
