We did not perform a formal power analysis but followed current standards in the field of EEG studies. Importantly, all analyses were based on within-subject effects. Furthermore, we aimed for a high number of trials per subject ($N > 400$) to minimize within subject measurement uncertainty (Baker et al., 2019). (Page 23)
