We have stated detailed information of sample size, statistical methods, methods of multiple test correction, and p values for all behavioral tests in the figure legends.

Biological replicates of behavioral tests were obtained in different days over a period of several months or longer, from different batches of animals.

All data were included.

Our behavioral tests were based on genotype and treatments. Experimenters were blind to genotypes until after the data had been collected and analyzed. All data were collected by video or camera recording. Many analysis were conducted automatically via image analysis by scripts in Matlab, details were stated in corresponding sections of Materials and Methods.
