We did not conduct a power analysis as we had no expectations before our experiments of what effects we might see or how big they might be. As we saw relatively low variability in our PCF experiments, we concluded that sample sizes of 5 - 10 would be sufficient. For unroofed membrane experiments, we used higher sample sizes of 10-20 as our preliminary results suggested that effect sizes might be small.

Number of replications for each experiment are indicated in their respective figure legends. Additionally, the number of replications for electrophysiology and fluorescence quenching experiments are also summarised in Tables 1-3. The definition of a replicate is described in the figure legends. Outliers were not discarded. We have added some additional sentences in the Materials and Methods section to describe exclusion criteria for data (lines 631-633 & 643-644).
