Replicates

Biological replicates indicate that experiments were performed with independent samples prepared at different times with consistent culture conditions. Biological replicates for qPCR experiments and determining the G2-phase length and meiotic entry rate are reported in Materials and Methods and Figure Legends. Biological replicates for all other experiments are reported in Figure Legends.



Statistical reporting
