No explicit power analysis was used. Various cell-free extract experiments were carried out and analyzed afterwards (which did not require sacrificing any animals), which showed clearly that wider tubes have a higher fraction of boundary-driven waves than thinner tubes (Figure 5). For statistical significance, see statistical reporting.

A table with an overview of all analyzed experiments can be found on the GitHub page which also contains the source code for the simulations. Figure 5 includes experiments with 66 different tubes. 49 of these tubes have a higher concentration of sperm chromatin (pooling tubes from 23 different cell-free extracts), while 17 use the lower concentration of sperm chromatin (pooling tubes from 7 different cell-free extracts). In total, 120 tubes were imaged using 30 different cell-free extracts, but only 66 tube experiments were used in the analyses as the other tubes did either not show any waves and/or did not show sufficient cell cycles.

Figures 5A,B show that wider tubes have a higher fraction of boundary-driven waves in both low dilution (A) and high dilution (B). This dependence is checked statistically using Pearson's chi squared test, giving p<0.02 in both cases (more precisely, p=0.0016 for the data in A and p=0.0199 in B).
