We based our study design on our other, recent proteomic analyses of HIV infection e.g. Greenwood et al., 2016; Naamati et al., 2019. The workflow for TMT-based proteomic quantitation allows multiplexing of up to 11 samples. Empirically, our analyses robustly identify outliers (differentially regulated proteins) in this type of study. An explicit power analysis was therefore not required.

Experimental workflows (including replication) are explicitly illustrated and described in the figures and figure legends, and our proteomic data analysis pipeline is detailed in the Materials and methods (subsection: Proteomics). All replicates are from biologically distinct samples, capturing random biological variation (biological replicates).
