Details on replicates as number of cells or days of experiments are provided in the Source Data Files associated to each figure. In addition, in most of the figures, single data points are plotted together with the mean and median. Data from CGCs are from 7 different cultures as specified on Source Data file – Figure 7. Data was analyzed for possible outliers using the GraphPad Outlier Calculator on line (https://www.graphpad.com/quickcalcs/Grubbs1.cfm) using the Grubbs' test with a significance level of 0.05 (Alpha). If Outliers were encountered, were removed from the data group. Importantly this test was run once per sample group.

#### Statistical reporting

Statistical analysis methods used are specified in each experiment or in Source Data Files associated with each figure, as well as exact p values obtained.
