Our study has not a character of an animal biomedical experimentation laboratory study. This is a behavioral study in which none animal suffered. Since there was no precedential experience for this type of study, it was also not possible to estimate a priori how many trials are required to get meaningful results.

Our study has not a character of an animal biomedical experimentation laboratory study. It is a behavioral study in which each trial was unique in that a certain dog was observed during homing at another locality at another time – i.e. combination of an individual (of different breed, sex, age, personality and experience), its motivation, space and time was unique and not replicable.
