No explicit power analysis was used to compute sample size during design of the study. For recordings of minis and of single fiber sizes, we stopped experiments once the sample mean stabilized after additional experiments. For recordings of short-term plasticity, a minimum of 9-10 cells was set as this number of replicates should be sufficient to reveal a difference between groups and has been used previously at the PC to DCN synapse (Turecek et al, 2017).

Sample size (number of cells recorded) is listed in the figure legend for each experiment. No responses from individual cells were excluded from the analysis. Where responses of individual cells are shown, outliers are displayed as well.

Means and SEM summarizing group data are indicated in figure legends and/or in text. As sample variances between wildtype and Doc2b KO were similar throughout the experiments, 1-sample t-tests were used for all analyses between wildtype and Doc2b KO. Exact p-values for t-tests are indicated in the text.
