As stated in the Methods, Results, and Fig. 3-4 legends, we performed 1,000 simulations for each unique combination of assumptions about screening strategy, subclinical fraction, and growing/stable epidemic context. Each simulation used a different candidate parameter set drawn using LHS. Each simulation considered a population of 30 infected travellers passing through screening.
