The number of fish in the behavioural experiments has been based on power calculations generated from a previous dataset of similar experiments (Dreosti et al. 2015). For these experiment we estimated that no more than 50 fish are required to achieve statistical significance at the $p < 0.05$ level. However, behavioural variance upon different treatments could be quite high. To achieve a similar precision at $p < 0.05$ level, we have increased the number of animals for some of the conditions.

Replicates

Each experiment has been repeated a minimum of three different clutches of different wild/type juvenile zebrafish. Since fish were tested in the behavioural experiments only once, only biological, and not technical replicates, have been performed. All the data has been included and described in the methods, results and/or figure legends.
