A sample size was not computed when the study was designed. Number of micrographs collected for single-particle cryo-EM structure determination are reported in the Methods section. Number of particles for 3D reconstruction are also reported in Table 1 and the methods section.

Complex formation were independently performed at least twice. FRET assays were performed independently in biological triplicates. Biological replicates are defined as replicates where experiments were set up fully independently from each other. No outliers were removed from the presented analyses. Further description of experimental setups are found in the methods section.
