No sample size was computed when the study was designed. Full retina knockout phenotypes were confirmed using two different Cres (*Six3-Cre* and *Chx10-Cre*). At least two litters per genotype and time point were used. Sample size can be found in the figure legends.

For all experiments, three to eight animals per genotype from at least two litters were used in this study at each time point, with wildtype littermates used as controls. Three to four images per animal were obtained for quantification, and all images were acquired at equivalent retinal eccentricities from the optic nerve head. There were no outliers. This information can be found in the Materials and Methods section.

LKB1^{F/F} mice from the same litters were used as littermate controls, while *LKB1^{F/F} Chx10-Cre* or *Cx57-iCre* were used as experimental animals. *AMPKα1^{F/F}α2^{F/F}* mice from the same litters were used as littermate controls, while *AMPKα1^{F/F}α2^{F/F} Chx10-Cre* were used as experimental animals.
