The sample size (n=15) of the clinical study was established in its study protocol based on results of previous studies with similar study set-ups of intraindividual comparisons. The significance level of false discovery rate was determined according to Benjamini and Hochberg ($q < 0.05$ confirmatory and $q < 0.2$ exploratory).

Replicates

Each animal experiment was repeated once (i.e. performed at least twice) as indicated in the section of statistical analysis, in the figure legends (e.g. Fig. 3), and/or given in the text (e.g. "Different set-ups (i.e. simultaneous treatment with dithranol and IMQ and pre-treatment with IMQ for 5 days followed by dithranol treatment) were tested, but similar effects were observed (data not shown).").



Statistical reporting
