Sample size estimates and power calculations were not performed as part of the study design as this is primarily a biochemical and structural biology study in which the experiments are internally controlled. Reproducibility in the biochemical and cell-based experiments was verified by repeating each experiment at least once with the appropriate controls included within the experiment.

The legend to Fig. 2 – figure supplement 2 indicates the number and type of replicates. Biochemical and cell biological experiments include internal controls that were performed as part of the same experiment. Each result or conclusion from the experiments shown within the paper is derived from at least two biologically independent experiments that both contained the same or similar internal controls. No attempts at replication with valid controls failed. These statements are provided in the Methods section under the heading “Statistics and Reproducibility”
