For secretion assay analysis, medium-size cultures are performed (20 ml into 125 ml flask). We carried out at least three biological replicates for all measurements from fresh transformation. No explicit power analysis was used. However independent triplicate measurement is a reasonable sample size in the field. For SMD simulations, a total of 50 windows was used, covering a range from +2 to -40 Å.

For each mutations, at least three biological replicates are performed. The OD⁶⁰⁰ is monitored during the experiment. For molecular dynamic, triplicate simulations of 500 ns have been performed. All statistical information is located in the figure legends and methods section.
