We did not employ a power analysis to estimate sample size, since we did not know what penetrance or magnitude of phenotypes to expect a priori. Moreover, one of the advantages of the zebrafish model is that fish lay large clutches with dozens to hundreds of fish. We were thus not limited by sample size in most experiments, and, conversely, limiting sample size would not have reduced the number of fish generated and sacrificed for the experiment.

Sample sizes were chosen to allow sufficient technical and biological replicates to have confidence in our results, achieve statistical significance, and make the scope of the experiment manageable in a reasonable time frame.

Information on sample size and replicates is included in the figure legends. All imaging experiments were repeated on at least two separate days, in at least three fish (and usually many more), and in multiple cells per fish.

All cells (expressing the appropriate reporters) whose entire perimeters were located within the frame of an image were included in analyses. No cells and no outlier data were excluded from analyses. Measurements of microridge length were made with an automatic image analysis pipeline, as described in the methods.
