We have used the ARRIVE guidelines for this study, which includes ethical statements (lines 461, 599, 923), fully described study designs and numbers of animals used for each test performed (see Table 2). Our funding sources are included in line 628. As part of our animal ethics permit requirements this study was required to minimize the numbers of animals used for each trial (this is stated in lines 599 + 923). We computed sample size estimates based on the fact that physiological studies in fishes typically require no less than 5-10 individuals in each group to provide accurate and repeatable estimates of response. Standards of our ethical permits follow the James Cook University (JCU) guidelines and Australian standards for animal research conduct and was assessed and approved by the animal ethics board of JCU.
