Sample size for the FACS-Seq experiments (20 to 25 million cells per replicate) were decided upon to ensure an ample number of cells per bin while being sortable while the cells were able to maintain a steady level of gene expression. Sample size for the experiments determining the gene-regulatory activity of individual switches (10,000 cells per replicate) was decided upon to ensure an accurate distribution of activities.
