We defined biological and technical replicates following the conventions of Blainey et al. (2014) *Nature Methods*, 11: 879-880. Biological replicates consisted of distinct parasite sample wells set-up and monitored in parallel for the duration of a given growth assay. Numbers of replicates for each experiment are given in the Methods section and in figure legends.

- 1. Growth assays: Individual data points in plots are the average ± standard deviation of 2-4 biological replicates monitored in parallel. Each growth experiment was independently performed 2-5 times on different days with different blood batches. No outlying data points have been excluded in plots.
- <u>2. Microscopy analysis:</u> Microscopy analyses were conducted in 2-3 repeat experiments on different days with different blood batches. For quantification, phenotypes were binned in discrete categories and counted for 20-40 total parasites across these independent experiments.
