Experiments were performed in at least three biological replicates. For qPCR experiments, technical and biological replicates are explained in the Material and Methods (Adult tissues RNA extraction and qPCR sub-paragraph). For single cell RNAseq we sequenced one batch of cells each for 48hpf, 72hpf, gcm MO and gcm control MO. Information on scRNAseq data is also described in Figure Legends 1,2, and 6. Transcriptome data are available and information for download is presented in the Materials and Methods (Single cell RNA sequencing sub-paragraph).
