This information can be found within the figure legends. Briefly, for electrophysiology experiments, each data point includes more than four biological repeats (>4 cells) and includes data acquired from multiple transfections and experiment days. FRET data included more than fifty biological repeats (>50 cells) transfected and imaged on multiple independent days. For molecular simulations 10 or more simulation repeats were created for each protein of study, as detailed in the "Methods". No simulation repeats that may be considered outliers were removed, and all reported information from simulations are described as averages or distributions across the entire dataset.



### Statistical reporting
