Control and test genotypes were analyzed in parallel as and where applicable. Each experiment was repeated independently at least three times. (N) Denotes biological replicate as each larva represents a distinct biological sample that is compared under similar conditions/ time points. All data were included in analysis and graphs indicate the scatter or distribution of data points. Values that are plotted in the graph have been provided in the source data for respective figures. Information regarding access to gene expression data is provided in the manuscript.
