The number of replicates of mice experiments were decided from past experience and practical considerations. Details can be found in the figure legends. For bulk RNA sequencing, 4 replicates were processed for each subpopulation. For the single cell RNA sequencing, 1 biological replicate per subpopulation was processed.

#### **Replicates**

In vitro studies on the cell lines (e.g. qPCRs, chemo assays, MTT) were performed at least 3 times starting from different frozen vials (biological replicates). For each biological replicate, 2/3 technical replicates were generated by dividing the same batch of cells in multiple samples depending on the assay. Details can be found in the figure legends.

## **Statistical reporting**

For each experiment, data are shown as mean  $\pm$ SD. IBM SPSS Statistics, R and Python were used for data analysis. The Mann-Whitney U test was used to analyze the difference between two groups of quantitative variables;  $\alpha$ -value was set at 5%. Information on the analysis of the sequencing data can be found in the Materials and Methods.
