Biological replicates indicate independent samples, while technical replicates indicate repeated replication of a given sample. For RT-qPCR, biological replicates were repeated using two groups of overnight cultured bacteria, and technical replicates were repeated at least twice with similar results (as the error bar shows). No outlier data we encountered. No data were excluded from the analyses. High-throughput sequence data have been deposited in Gene Expression Omnibus (GEO) under accession number GSE151518. For the reviewing purpose, the private token "epwbqouehtczvkf" should be used.
