The current research advance was conducted computationally on datasets from previous studies. All available data from the original study (N = 11 mice; Hoekstra et al. 2019) were used for the main experiment. Data for analysis of same individuals with different sleep deprivation durations (N=9 sessions in 5 mice) was taken from Hubbard et al. 2020. An additional existing unpublished dataset (N = 5 mice) was tested in the final generalization analysis. Further details on the datasets can be found in first paragraph of Methods section.

Replicates

No experiments or replicates were performed in this study. One session with abrupt discontinuity of temperature data due to technical problems was excluded. Other artifacts were handled as described in 'Data Acquisition' section.

The general statistical approach used is explained at Methods section in the 'Units and Statistics' section. All empirical temperature data for the main analysis and final generalization on independent individuals, are presented at the figure 3 and last supplementary figure. The second dataset for inter-individual tests is less informative and only summarized in a table. The number of biological replicates ('n') can be found in the graphs and/or in the text. Statistics on data that is not visualized are mentioned in the main text.
