This information can be found within the methods section of the manuscript. The team aimed to obtain at least 50 responses from editors in each discipline. Therefore, assuming a response rate of approximately 20%, we conservatively decided to invite 300 journals per field.

Our survey was designed to survey at least 250 of 1500 high-impact journals one time about their peer review policies. No data was excluded.

All quantitative findings have been reported descriptively. The only statistical analysis performed was the generation of unweighted kappa coefficients to assess the reliability of the qualitative analysis which we believe is described in sufficient detail in the methods section. All figures and tables (except Figure 2*) contain exact values of N. (*For simplicity a link to the raw data underpinning Figure 2 has been listed in the figure caption.)
