Sample size calculation was performed based on previous results of calculation of mechanical stresses in histopathological samples, resulting in a minimal sample size of 7 lesions per group in order to achieve α =0.001 and power of 0.95; this was then arbitrarily rounded to 10 lesions per group.

Statistical reporting
