No explicit power analysis was used in this study. Obtaining detailed late gadolinium enhanced magnetic resonance imaging from embolic stroke of undetermined source (ESUS) patients is difficult and only 45 viable scans were available to use. We chose to use 45 atrial fibrillation (AFib) control patients to match this number.

Given the computational nature of this research, replicates of our deterministic computational simulations are not necessary. Inclusion/exclusion criteria can be found in the Methods section under the subsection patient population and MRI acquisition.

Samples were allocated into the ESUS group if they met published criteria (i.e. suffered from a stroke of undetermined source and lacked atrial fibrillation). Patients in the AFib group either had paroxysmal (27/45, 60%) or persistent AFib and without stroke.
