Statistical reporting is described in the Results under sections Target genes of the master biofilm regulators differ greatly among *Candida* species, High connectivity of the biofilm network is observed in all four species, and Biofilm specific gene expression changed rapidly over evolutionary time; in Methods under section *De novo* sequence motif discovery and enrichment for the regulators; and legends of Figure 2, Figure 3 and Figure 4-figure supplement 1.
