# Statistical reporting

All statistical analysis methods are described in the "Statistics" section in "Methods." Individual electrode data and technical replicates are included in main figures where appropriate. Otherwise, these data are provided in supplementary figures. All relevant p-values, significant and non-significant, are included in the text. We report exact p-values except when p-values are very small (p < 0.001) or when discussing multiple p-values for a large group.

A small set of additional data was collected in a second participant. The participant from whom the data was collected is indicated throughout the documents with "P2" or "P3." Tested electrodes were provided with the same stimulus parameters and were only grouped based on post-hoc analysis. How we divided electrodes based on their responses is described in the "K-means clustering" section of "Methods."
