The sample size has been computed when the study was designed, based on a power of 0.95 with an alpha level of 0.05 and assuming an effect size of $\eta^2 = 0.08$ (previous effect of L-DOPA on extinction memory consolidation) using G*Power 3.1.9.6
This is stated in the manuscript on page 19 in the Materials & Methods section under „Participants“

This experiment has only been performed once. No outliers have been removed in any analyses. Number of participants are included in each figure and statistical analyses throughout the test. Criteria for inclusion of individual outcome measurements are stated on page 21ff for each outcome measure.
